

## Revenue Sharing and You

It's possible that you have heard the term "revenue sharing" in the news. Like many, it may come across as one of those "government" words that you don't completely understand.

Did you know that revenue sharing helps pay for essential services that keep you safe? Or that revenue sharing helps us maintain the roads within the township? It does these things and much more. Revenue sharing has a direct impact on you as a resident of Nelson Township.

### What exactly is revenue sharing?

Revenue sharing is money that local governments, such as townships, cities, villages and counties, receive from the state. Revenue sharing was established in 1946 by a vote of the people through a constitutional amendment to replace and relieve local taxation. The state promised to give local governments a portion of the money it received from other state taxes, including the sales and income taxes, and the Single Business Tax. The primary purpose of revenue sharing, when first implemented, was to limit local taxing authority while increasing state taxing authority, with the idea that a predetermined amount would be shared with the local government on a per capita basis.

Revenue sharing was designed to be flexible, non-restricted funding that a community could use to best fit its needs. Local communities rely on revenue sharing to pay for services that directly impact your lives.

There are two types of revenue sharing in Michigan: statutory revenue sharing and constitutional revenue sharing. In 1996, the state stopped distributing revenue sharing from the income tax, Single Business Tax and intangibles tax, instead dedicating a percentage of the first 4 percent of the sales tax to revenue sharing. Constitutional revenue sharing is funded by taking 15 percent of the first 4 percent gross collection of the state sales tax. Statutory revenue sharing is funded by using 21.3 percent of the 4 percent gross collections of the state sales tax. The remaining 63.7 percent of revenue from the 4 percent gross collections is used to fund other state obligations. The remaining 2 percent of sales tax collected is dedicated to the school aid fund.

Due to the method used by the State Legislature to cut revenue sharing in order to balance the state budget, of the 1,242 townships across the state, less than 300 townships receive any amount of statutory revenue sharing. More than 945 townships receive only constitutional revenue sharing. Nelson Township receives constitutional revenue sharing only.

### So how does this affect life in Nelson Township?

Revenue sharing funding, although promised by the state, is also at the mercy of the state's economy and how much revenue the state takes in each year. In recent years funding for revenue sharing has seen dramatic cuts as the state's economy has lagged. And as we look to future years, with skyrocketing gas prices and people cutting back on extras, revenue from sales tax could decrease, further impacting our revenue sharing funding and local services.

As lawmakers in Lansing battle over the 2008-09 fiscal year budget, which begins on October 1, 2008, revenue sharing is once again high profile topic. Now more than ever money that local communities rely on to pay for essential services, that directly impact your lives, is continually being threatened. It is important that the township, on behalf of their residents, receives the appropriate level of funding to assist with local services.

Here at Nelson Township, we are doing all we can to make sure our state representative and senator are aware of how revenue sharing impacts our community. Just like you are counting on us to make this community a better place to live, we are counting on Lansing lawmakers to make sure we receive proper funding from the state.

# Clerk's Corner

This is an election year.

Presidential Primary – Tuesday August 5, 2008  
Presidential Election – Tuesday November 4, 2008

### Register to vote

You can register to vote by mail or in person. You must register 30 days prior to an election.

### Absentee ballots

As a registered voter, you may obtain an absentee voter ballot if you are:

- age 60 years old or older
- unable to vote without assistance at the polls
- expecting to be out of town on Election Day
- in jail awaiting arraignment or trial
- unable to attend the polls due to religious reasons
- appointed to work as an election inspector in a precinct outside of your precinct of residence

### How do I get an absentee voter ballot?



Your request for an absentee voter ballot must be in writing and can be submitted to the township clerk.

Your request must include one of the six statutory reasons and your signature.

You must request an absentee voter ballot by mailing the online application, a letter, a postcard, or a pre-printed application form obtained from your local clerk's office. Requests to have an absentee voter ballot mailed to you must be received by your clerk not later than 2 p.m. the Saturday before the election.

Once your request is received by the clerk, your signature on the request will be checked against your voter registration record before a ballot is issued. You must be a registered voter to receive an absentee ballot. Requests for absentee voter ballots are processed immediately. Absentee voter ballots may be issued to you at your home address or any address outside of your city or township of residence.

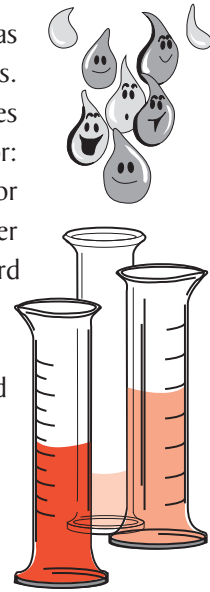

# Free Water Test Kits

The Kent County Health Department has supplied our office with water test kits. Each kit contains two collection bottles and instructions for testing your water for: drinking water coliforms, fecal coliforms for surface/wastewater, swimming pool water coliforms, non-potable water standard plate count-pools and automated partial chemistry, including fluoride, chloride, hardness, nitrate, sulfate, sodium and iron.

Analyzing fees are \$15.00 and \$17.00 dollars. Samples may be mailed or taken directly to the Heath Department.



# Treasurer's Tidbits

### Treasurer's Hours:

Monday through Thursday: 9 a.m. – 3 p.m. and Monday, September 15, 2008 from 9 a.m. – 5 p.m. September 15th is the last day to pay summer taxes without penalty.

There is a drop box at the Township Hall's main entrance for your convenience.

You may go to the township website and get your millage rates and estimate your taxes.

### Deferred Payments:

For those who qualify for Deferred Payment of their 2008 Summer Taxes, applications are now available at the Nelson Township Treasurer's office. Filing of this form is voluntary. However, your tax due date will not be extended unless it is certified each year with the Township Treasurer by September 15.

# From the Assessor's Office

This summer and fall, the Assessor's Office will begin work on digitally photographing each dwelling within the Township. The photographs are used for assessing purposes and are maintained as part of the property record card system as we continue to shift to an all digital record system. Any person photographing buildings will have picture identification with them.

Also, in accordance with state guidelines stating that properties be re-inspected every five years, I am planning on visiting those homes in the following areas: Carolyn Drive, and Wildwood Lane and Court, and will be visiting select homes in the Metes & Bounds description properties in the township. I will have identification and will provide it upon request

If you plan on splitting your property, you must file a land division application with the assessor. Land division applications are available at the township hall or on the township website [www.nelsontownship.org](http://www.nelsontownship.org)

Other forms available on the website include: Property Transfer Affidavit, Homeowner's Principle Residence Exemption Affidavit, & Request to Rescind Homeowner's Principle Residence Exemption.

The Assessor's normal office hours are Monday's and Thursday's from 9:00 to 3:00.

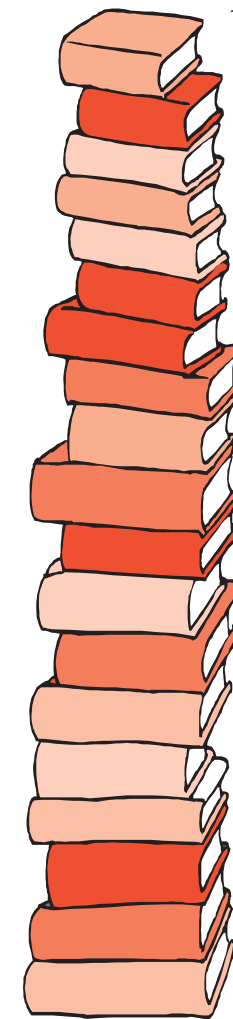
Nelson Township is taking applications for positions on the Planning Commission, Board of Review and Zoning Board of Appeals (you must be Township resident).
